The statement shall not be older than six months on the date on which the notice was sent.

4. Confirmation of the tax administration:

If economic operator has not fulfilled the obligation to pay outstanding tax liabilities and obligations for pension and health insurance, unless the economic operator in accordance with special regulations approved deferred payment of those liabilities. For the purposes of proving the circumstances referred to in this point of economic entity is obliged to offer to submit a certificate of tax administration on the debt or equivalent document of the competent authority of the host state of the economic entity, which may not be older than 30 days on the date on which the notice was sent.

5. Evidence of legal and business capacity:

A copy the certificate of the registration with the business, court (commercial) professional, trades/crafts or other appropriate register or an adequate certificate proving that a bankruptcy procedure is not pending, that the economic operator is not in the procedure of liquidation or in the procedure of winding up his business activity or that he has not wound up his business activity, or the evidence that the economic operator holds an authorisation, approval and the like that he needs in the country where he is established in order to perform activities related to a subject-matter of procurement or a certificate of membership in a specific professional organisation which is mandatory in the country where he is established in order to perform activities related to the subject-matter of procurement.

If the evidence is not issued in the country where the economic operator is established, the contracting authority may request the economic operator to provide an appropriate statement with the signature certified by the competent authority.

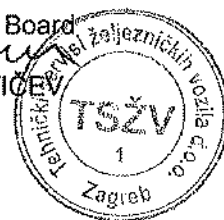
